**Administrator's Report**

Elementary Principal's Report

Jamie Halley presented the Elementary attendance rate of 96.63% for November with enrollment of 158 students. End of second quarter and first semester is December 18th.

Office referrals were discussed. Math Review, Math Facts, STAR Reading, and STAR Math scores were reported.

Chromebooks have been delivered and set up for Elementary use.

High School Principal's Report

Jamie Tipton presented the High School attendance rate of 95% for December with enrollment of 125 students. Behavior Report, Grade Report, and STAR Data were discussed.

FFA fruit sales are complete. Projects in the Ag construction class are being completed and will be ready to sell in the near future. Band performed a Virtual Christmas Concert this year.

There are 12 students participating on the Dance Team. They will perform at home basketball games. The High School Boys Basketball team has a record of 6-1 and they placed 3<sup>rd</sup> in the Northwestern Tournament. High School Girls Basketball team has a record of 5-2 and they placed 2<sup>nd</sup> in the Northwestern Tournament.

Staff is continuing professional development with technology and use of Google Classroom.

The second quarter and the first semester will end on December 18, 2020. There is no Holiday Hoops this year but basketball teams will play at Madison on December 21<sup>st</sup> and at home against Princeton on December 29<sup>th</sup>.
