Elementary Principal's Report

High School Principal's Report

There are 48 students in 7-12 band. The band is participating in 7 marching contests/parades. They are preparing for Pep Band. Choir attended the District competition in Moberly.

Baseball ended the season with an overall record of 9-1 and 8-0 in Conference. Green City was named Baseball Conference Champions. Laydon Fields, Grant O'Haver, and Aaron Peavler were named 1st Team All-Conference. Brody Lunsford was named 2nd Team All-Conference.

Softball has a record of 5-11 overall and 3-5 in Conference. Celeste Athon was named 1st Team All-Conference and 1st Team All-District. Paige Pialet received 2nd Team All-District. The All-Express Team will be decided by Thanksgiving.

Junior High Boys Basketball was 13-0 overall and 8-0 Conference Champions, and they won the Bucklin Tournament.

Junior High Girls Basketball was 11-2 overall and 7-1 in Conference. They placed 2nd in the Bucklin Tournament.
