**Administrator's Report**

Elementary Principal's Report

Jamie Halley presented the elementary report with a current enrollment of 157 students and an overall attendance rate of 92.46%. Mrs. Halley shared parent-teacher conferences were held March 17, 2022 and the preschool and kindergarten screening will be held Friday, March 18, 2022. Student academic data was also presented.

High School Principal's Report

Jamie Tipton presented the high school report with a current enrollment of 126 students and a February attendance rate of 95%. Mr. Tipton also shared discipline data. He provided an update on the Ag/FFA program, as well as final information related to winter sports and initial information related to spring sports activities.

Superintendent Report

Mrs. Banner presented a proposed timeline for investigation of a 4-Day School Week.

**Old Business**

Mrs. Banner presented information regarding proposed changes to the 6th grade for the 2022-2023 school year.

Jason Salas moved, second by Ryan Barnes, to approve allowing 6th grade students to participate in all allowable MSHSAA sanctioned events beginning with the 22-23 school year. Motion passed by a vote of 6-0.

Tennille Banner requested to amend the 21-22 school calendar to make Tuesday, March 1, 2022 an early release day at 12:45. Jason Salas moved, second by JT Thomas, to approve the changes to the 2021-2022 School Calendar as presented. Motion carried 6-0.

Insurance Rates for 22-23

Mrs. Banner presented health insurance rates for the 22-23 school year. Thomas Christen moved, second by JT Thomas, to approve the district to approve \$750 per month towards health insurance and approving the presented rates for the vision and dental. Motion carried 6-0.

Copy Machine Purchase

Mrs. Banner presented information regarding the purchase of a new copy machine for the elementary building. Ryan Barnes moved, second by Jason Salas, to purchase the Kyrocera copy machine at a rate of \$6,220. Motion carried 6-0.

Preschool Transportation

Mrs. Banner presented information in regards to allowing preschool students who are 4 years of age to ride the school bus for daily routes. Thomas Christen moved, second by Ryan Barnes, to allow 4 years olds preschool students to begin riding the bus effective the 2022-2023 school year as long as the family has agreed to, and signed the preschool transportation agreement. Motion carried 6-0.

Conference Campus Bowl

Motion by Ryan Barnes, second by JT Thomas to pay \$12 per game, per worker for the Conference Campus Bowl tournament. Motion carried 6-0.

Jason Salas moved, second by Ryan Barnes, to enter Executive session to discuss RSMo 610.021.6 Students and RSMo 610.021.3 Personnel at 8:16 p.m. with a roll call vote of Barnes-yea, Christen-yea, Hatcher-yea, Thomas-yea, Lee-yea, Salas-yea.
