Elementary Principal's Report

Jamie Halley presented the Elementary attendance rate of 93.52% for March with enrollment of 156 students. Midterm is April 14th. Elementary Track and Field Day is scheduled for May 16th. Mother's Day Tea is scheduled for May 6th at 2:30 p.m. for Preschool through 2nd grade. Elementary Awards and Promotion night will be held May 11th. The last day of school is May 19th.

High School Principal's Report

Jamie Tipton presented the High School attendance rate of 95% for March with enrollment of 125 students. Behavior Report, Grade Report, and STAR Data were discussed.
