Administrator's Report

Elementary Principal's Report

Jamie Halley presented the Elementary overall attendance rate of 95.78% with enrollment of 133 students. Office referrals were discussed. Accelerated Reader, Math Facts, STAR Reading, and STAR Math data were discussed. Second Quarter Midterm is November 16th. The Elementary Fundraiser with Mama Jane's Dip Mixes will be November 18th through December 1st. STAR Testing will be November 28th through December 9th. PTS is being reestablished with some activities and fundraisers coming up in November and December. Parent-Teacher Conference attendance was 91%, all but 12 students' families attended.

High School Principal's Report

Jamie Tipton presented the High School attendance rate of 95% for the month of November with enrollment of 136 students. Behavior Report, Grade Report, and STAR Data were discussed. FFA students are applying for SAE grants. The LDE/Speech season has started. Mrs. Becky Tipton was awarded a \$400 classroom grant from ADK. Fruit Sales have ended with deliver the first week in December. FFA is selling Kettle Corn as a class research project for cost analysis and marketing. Band is preparing for Pep Band. Honor Band at Truman was November 14th. Junior High Basketball teams both had successful seasons. Dance has 13 students participating. Cheerleading has 11 students participating. Green City hosted a High School Basketball Jamboree on November 14th. The Fall Sports Banquet will be November 17th.
