RENEWAL OF AWARDS

Federal aid programs, state financial assistance, and NCMC Foundation scholarships require that a FAFSA be filed each year to determine eligibility. Renewal criteria varies for each award. Satisfactory Academic Progress (SAP) must be maintained to continue receiving financial aid. Renewal guidelines and the SAP policy can be found in our Academic Catalog (Financial Aid) on the NCMC website *ncmissouri.edu*.

DISCLOSURES

Enrollment in classes indicates your agreement to policies as stated in the catalog and student handbook, including using student aid for educational purposes only. For detailed Student Consumer Information, please visit ncmissouri.edu/consumerinfo/. Paper copies of consumer information are available upon request to the Vice President of Student Affairs.

Awards may be adjusted due to verification of changes to your FAFSA, receipt of additional aid from outside sources, changes in your enrollment level, and adjustments to our federal and state budgets.

Financial aid may only be applied to courses required for your declared degree(s) and/or certificate. It is your responsibility to check with your advisor to ensure you are enrolled in only courses within your academic plan.

No student who is incarcerated may receive Title IV student loan funds, and no student who is incarcerated in a Federal or State penal institution may receive Pell Grant funds. Students are required to disclose their incarceration status at the

time of acceptance and/or if they become incarcerated while enrolled at NCMC. Notification should be made to the Office of the Registrar.

To receive student loan funds a student must be enrolled in and attending at least half-time status (6 or more credit hours).

The U.S. Department of Education pays the interest on a Federal Direct <u>Subsidized</u> Loan while you're in school at least half-time, for the first six months after you leave school, and during a period of deferment. You are responsible for paying the interest on a Federal Direct <u>Unsubsidized</u> Loan during all periods.

A loan fee is subtracted directly from a loan before it is disbursed to you. This means you will receive a smaller loan than the total amount that you actually borrowed, but you will still be responsible for repaying the entire amount that you borrowed.

To be eligible for the A+ Scholarship award, you must be enrolled in at least 12 credit hours during the fall and spring semesters or at least 6 credit hours in the summer semester. Renewal students must maintain a cumulative GPA of 2.50 or higher. Award amounts are estimated and may be adjusted based on enrollment at the time of disbursement.

To receive the Access Missouri Grant, you must be enrolled full-time (12+ credit hours) and meet state eligibility requirements. Renewal students must maintain full-time enrollment and a cumulative GPA of 2.50 or higher. This award is estimated and may change based on State appropriations. Per state guidelines, the Access Missouri Grant must be reduced by the amount of A+ Scholarship received.

NEXT STEPS

1) Submit any missing financial aid documents

A major hurdle to being successful is completing the paperwork required to receive your aid. Make sure to check your myCOMPASS (Finances/Financial Aid) and Pirate email account to ensure any missing financial aid documents have been received (loan documents optional). No access to myCOMPASS or Pirate email? Your next step is to apply for admission to NCMC! Visit ncmissouri.edu and click Apply!

2) Provide transcripts for other colleges

The amount of aid you qualify to receive is partly based on your grade level. Make sure we have all of your academic records so that we can ensure you receive the most aid to help you afford your education.

3) Inform us of any additional aid you receive

It is a federal requirement to make sure that we are informed of any aid you receive to assist in paying educationally related costs. Forward any information about such awards to make sure we process your aid correctly.

4) Apply for Federal Work Study jobs

Work study jobs are posted on the NCMC website ncmissouri.edu. Positions are limited, so begin applying soon!

5) Apply for a Student Loan

Student loans are OPTIONAL and must be repaid. Student loan information, including the loan request form, can be obtained through myCOMPASS > Forms & Policies.

6) Plan for "non-billable" charges

Not all costs to attend are paid to NCMC. Off-campus rent, transportation, and most books are examples of costs you will need to include in a budget.

7) Contact your friend in Financial Aid
